Recreation Scholarship Guidelines

In order to qualify, your household's monthly gross income must fall within the Income Limits shown on this sheet. You must provide SSI Statement, the most recent year's tax form, or TANF paperwork.

All adults in the household must provide proof of residency.

Scholarship assistance will be determined by Vancouver-Clark Parks and Recreation Scholarship Program Staff, on a case-by-case basis. The average is \$30 per person per term, and no more than \$150 per family, subject to change. Adults may not use children's allotments, but unused adults' allotments may be applied to the children's registrations.

One application/registration per household may be submitted per registration period. Registration periods are December-March, April-July, August-November.

Please indicate on this form the classes you and your family wish to sign up for this registration period. Allow one week for approval. If you are approved, and the class has openings, you will receive notification and a receipt confirming you and/or family members have been successfully registered.

With the privilege of scholarship comes responsibility. There may be a wait list for your spot in class, so please call five working days prior, if you can't attend, or you might jeopardize your being considered for future scholarship awards.

Example: if three people live in your household, the gross family monthly income must be less than \$2,625 in order to qualify for a Recreation Scholarship. (HUD 50% of area median)

If program funds run out during the year, it is possible the scholarship program will need to be halted, and assistance for all will be denied until funding is renewed.

A family pass to one of the centers may be purchased with scholarship dollars; however, a family may not use the allotment of a child under 4 years old to obtain a larger discount on a pass.
