SUBJECT: City of Vancouver City Street Tree Worker License Requirements

Beginning May 2007, any person who wants to perform major pruning on street trees within the City of Vancouver must secure the appropriate street tree permit and hold a valid City Street Tree Worker License. The City will start accepting applications after January 1, 2007.

If your company qualifies for a Street Tree Worker License, your company will be placed on a list of tree care contractors qualified to perform major pruning work within the City on street trees.

The following is a list of the items required by the City of Vancouver before a Street Tree Worker License can be issued:

- City Street Tree Workers License Application
- List of ISA Certified Arborists on Staff
- Vancouver Business License (copy)
- Proof of Liability Insurance of \$1,000,000 (copy)

The City Street Tree Worker License expires one year from the date of issuance or sooner if the liability insurance or ISA Certification of Staff lapses. The City will suspend the license when the licensee commits any of the following acts: Knowingly violates any of the provision of the Street Tree Ordinance or the standards established in the Street Tree Manual; knowingly conspires with another person by permitting one's license to be used by such other person unless employed by the licensee.
