ATTENTION ELECTRICAL PERMIT APPLICANTS **New Electrical Code in Effective July 1, 2005**

Effective July 1, 2005 the City of Vancouver will begin enforcing the **2005 National Electrical Code**, adopted by the State of Washington as the minimum State Electrical Code.

The **2005 National Electrical Code** as adopted by the State of Washington will be applicable to all permits applied for July 1, 2005 and later.

Electrical Permits applied for or obtained prior to July 1, 2005 are vested under the 2002 National Electrical Code as adopted by the State of Washington and Vancouver Municipal Code Title 17.16 (VMC) and will continue to be subject to the provisions of that code.

Until the City of Vancouver updates VMC 17.16 with references to the 2005 National Electrical Code, the local provisions contained in VMC 17.16 are applicable.

State Electrical Code WAC Rules relevant to procedures for permits and inspection are not applicable to the City of Vancouver. Please see VMC 17.08 for regulations regarding permits, inspections and enforcement.
